Tampa is the largest city in Florida's Tampa Bay area and also the seat of Hillsborough County. Hillsborough County experienced the first wave of coronavirus cases in July 2020, followed by another rise in January 2021. Starting July 2021 the daily cases also steadily rose, peaked in August 2021, and then saw a gradual decline all throughout the rest of the year. As of the time of writing, Hillsborough County has recorded a total of over 245000 coronavirus cases and has registered around 3100 deaths.

Since the pandemic began, city and county officials regularly issued the necessary orders and recommendations to curtail the spread of the deadly virus. Tampa Mayor Jane Castor issued an executive order declaring a state of local emergency on March 12, 2020. The state of emergency was extended several times over the year and well into 2021. There were exceptions for essential service providers to make sure

that critical services were still functioning. In a mayoral order issued on March 17, 2020, the city limited the hours of operation and on-premises consumption of food and beverage in restaurants, bars, private clubs, and other establishments, limited the size of gatherings, and closed public beaches.

The coronavirus also affected popular entertainment events scheduled all throughout the year. The 2020 edition of Wrestlemania was held behind closed doors to an empty audience. The NCAA also canceled all men's and women's basketball tournaments that were part of its March Madness event, eliminating the first-round games at Amalie Arena and a number of other college sports. Even as sports returned to the city, they did so with plenty of reservations about their safety, as experts expected a spike in coronavirus cases following the 2021 Superbowl event.

The stay-at-home orders and lockdowns affected businesses which in turn affected the common folk that worked those professions. Between March and April 2020, Tampa lost 11.4% of its workforce to downsizing as the pandemic made most businesses that operated in the retail and hospitality businesses unsustainable. It was only in October 2021 that the city managed to get employment numbers back to where they were before the pandemic hit. However, the damage was already done as, in the interim, scores of city residents had to rely on the relief provided by the local government and federal programs such as the CARES (Coronavirus Aid, Relief, and Economic Security) act of 2021 to afford basic necessities such as housing and food.

Readers who were directly affected financially by the pandemic and who are dealing with the same struggle as many others from Tampa are facing, can turn to Bravafi for help. Bravafi - Tampa's application process is straightforward and quick. The applicant has to complete an online form by filling out information about their vehicle. The entire process takes less than 2 minutes. Once the company receives the information, it starts the verification process. If the details are verified to be accurate, the company asks the applicant to send supporting documents such as their ID, driver's license, proof of income (minimum \$1500 a month), and their vehicle's title. The company will then disburse the funds by cash, check or deposit, in some cases, as soon as 24 hours. The company says that applicants have a 95% chance of getting approved and the approval time can be as low as 15 minutes.

A spokesperson for the company talks about the feedback it regularly receives from its customers by saying, "It's always a nice feeling when a customer tells us how we helped them when nobody else would or could...that's what we do and it's just great to hear it from the residents in Tampa."
