Charles Sanders explains, ?In Texas, personal injury claims are typically based on the theory of negligence. To succeed in court with a case related to this legal theory you must prove that your injuries were caused by someone?s fault and not just bad luck or coincidence; they need to have been careless enough for proof through the preponderance of evidence - meaning that your injury claim is more likely valid than invalid.?

To succeed in their case, plaintiffs will generally have to demonstrate to the court the presence of five factors: duty, breach of duty, causation, proximate cause, and damages. First of all, it must be shown that the defendant had a certain duty to act or not act in a certain way that would have prevented the incident. Second, there was a breach of duty or the defendant failed to do his or her duty. Causation has to do with the circumstances under which the breach of duty resulted into the injury suffered by the plaintiff, as opposed to the incident being mere coincidence. It must be shown that the defendant?s breach of duty was the proximate cause of the injury. And finally, evidence must be provided to show that the plaintiff suffered damages.

Demonstrating the above factors is not always easy because there are many variables to consider. For instance, in a car accident, there are many possible contributors to the accident, such as weather conditions, road conditions, or speed limits. It is therefore essential to get the services of an experienced lawyer who is familiar with the various factors that may contribute to a car accident.
