Some of the personal injury claims that are being presented commonly are: car accidents, wrongful death, slip and fall accidents, sexual abuse, motorcycle accidents, personal injury, truck accidents, among other serious claims.

In the article, Mr. Leigh also discussed: "If you are injured in an accident caused by negligence or carelessness of another person, that person can be held liable for your injuries, costs, as well as any other

damages. The responsible parties may vary depending on the type of accident or where it occurred.?

Furthermore, the lawyer explained how insurance companies can be highly profitable public companies, and that they are accountable to their shareholders. Adjusters are aware that their job is to save money.

To keep their costs low, insurance companies commonly use low-ball settlements. A small settlement can limit the victim's financial exposure and complete the claim. Injured victims often feel so relieved to receive a settlement, that they don't realize that it won't be nearly enough to cover all of the expenses.

Personal injury claims can take a while to fully understand the severity of the injuries as well as the related costs, both short-term and long-term.
