In addition to helping their case, this documentation might be helpful if the patient requires additional treatment in the future.

Notably, physical injuries are not the only reason why compensation may be needed. Damage to the victim?s vehicle, any possessions within, loss of wages and so on can have a large financial impact even if they leave the accident in perfect physical health. If they are able to, it is recommended that they take pictures of the scene, including the damage to both vehicles and their position. The lawyers at Kenneth S. Nugent, P.C. - Augusta can use these photos (and other evidence they can independently collect) to determine the extent of the at-fault party?s responsibility and how much compensation is due.

In the event of serious injury or similar circumstances that mean the individual in question is unable to leave the hospital or their home, the firm is ready and willing to dispatch a case Investigator on their behalf. They will provide a free case review to determine the extent of their injuries and auto accident claim.
