injury was minor, involved only a little lost work time, or the employer had readily agreed that the illness or injury was work-related. However, if the injuries are severe and the circumstances are disputed or complicated, a knowledgeable and experienced workers comp lawyer is vital for the injured worker.

One example involves Zantac, which had contamination issues after testing showed the presence of N-nitrosodimethylamine, a suspected human carcinogen. Another product that has been involved in lawsuits is the hernia mesh, which is used to correct hernia. Common complications involving the hernia mesh are infection, adhesion, pain at the implant site, and bowel perforation or obstruction. The firm has also been involved with product liability claims against talcum powder, which has also been implicated in ovarian cancer for women who used it in the genital area.
