Insurance covers the vast majority of slip-and-fall injuries. However, insurance companies are not often willing to pay such claims. Slip and fall injuries are difficult to prove. Insurance companies can make it difficult or impossible for an injured party to be compensated.

Another common personal injury in New York is nursing home abuse. Today, approximately 1.4 million Americans live in nursing homes and assisted living facilities. These numbers are increasing with the aging baby boomer population. There are many reasons people choose to live at these facilities.

In most cases, the residents of nursing homes will be older or disabled individuals who require long-term care. This may include assistance with eating and cooking, dressing and bathing, personal hygiene, movement, and medical attention. Assisted living facilities are meant to provide sufficient care and a safe environment for residents, but abuse and neglect are increasing in number.

Furthermore, Ms. Kucher discusses another common personal injury which is wrongful death. ?It is difficult to bear the grief of losing a loved member of the family. It can be especially distressing when the death was caused either by negligence or intentionally. Family members can be devastated by the loss of a loved member.? says the personal injury attorney.

Unlawful death claims seek a monetary award from the at-fault party for damages to compensate family members for losses that result from the death of a loved one.
