Total Pool Safety Solutions Is Sharing Above Ground Pool Fence Regulations Enforceable In QLD

The company recently released a blog post that talks about the above ground pool fencing requirements that are in effect in all of Queensland.

Above ground and inflatable pools have seen a rise in popularity in Australia due to their potential for enjoyment for the whole family, their utility, their ease of installation, and their comparatively lower cost of construction. However, they pose just as much of a risk as an inground pool if they are not properly maintained or installed. Total Pool Safety Solutions says in its blog post that it is necessary to adhere to all safety regulations to ensure a fun and wholesome time for the homeowners while avoiding the risk of bodily harm. Pool fencing laws are designed to serve many purposes such as preventing accidental drownings and especially preventing injury to children in private swimming pools.

A pool barrier is usually required for shallow water bodies that are at least 300mm in depth. In Queensland, the pool barrier must be a minimum of 1200mm from the ground to the top and not easily climbable. If the

fence is less than 1800mm then climbable zone objects must be at least 900mm away from the pool barriers on the outside. The pool barriers should surround the entire outside area, even if it is just grass or dirt. This rule also applies to inflatable pools. According to the requirement of most states and counties in Australia, a fence or barrier of at least 4 feet must be placed around any pool that is more than 18 inches in depth. The pool gate to the backyard must self-close and self-latch while still remaining functional for emergency personnel. A safe alternative to the gate is a lockable fence panel that can be removed when necessary without compromising safety.

The pool-compliant barrier should be installed and maintained at all times, not just at the time of a pool safety inspection. Pool barriers and fences must be compliant with the Queensland Development Code MP3.4 - Swimming pool barrier. This code modifies and calls up the Australian Standard AS1926. All existing and new pools and spas must be registered on the Pool Safety Register with the QBCC (Queensland Building and Construction Commission). A Building Approval is required for pools according to the local building code. They must also meet the fencing requirements and have a compliant pool barrier.
