Unfortunately, it must be noted that the existence of a court order to this effect does not necessarily mean that it will be implemented properly. Similarly, circumstances may change for one or more parties as time goes on, in which case child support (or spousal support) will need to be reconsidered. The firm recommends that parents take their concerns to a reputable family lawyer at this point for advice on how their previous support orders may be affected.

For instance, if the child support order was put in place when the spouse was unemployed, then gaining employment can have a large impact on the support that is due. The converse is true as well. Amundson reminds her clients that losing a job or suffering similar economic setbacks does not necessarily mean they should still owe an amount they may no longer be able to reasonably afford. However, the standing child support agreement will continue to be in effect until it is re-evaluated so prompt action is vital in such situations. Notably, however, the needs of the children will likely continue to take precedent.

A divorce can be incredibly difficult to go through, and this is exacerbated if one or more parties is hostile to the proceedings. However, having a capable attorney by their side can help a client navigate this trying time of their life with minimal delays or stress.
