Every year, the US Medicare program loses billions of dollars as a result of deceptive activity perpetrated by people and companies that work with the program. This type of fraud has an effect on each and every taxpayer and is a huge drain on the Medicare program. Considering the government's lack of resources and holding defrauders responsible, it must count on private health care employees in the industry to come forward with information so they can hold those who defraud the program responsible.

"Fraud against the Medicare program may take many forms," said the New Jersey whistleblower lawyer "The Fraud can be manipulating healthcare records to earn more from Medicare, surcharging the government, providing second-rate services or products, and many other activities. The government depends on private whistleblowers to come forward with direct knowledge and proof of this conduct and the government compensates them for their crucial support. Through qui tam claims, whistleblowers are able to bring civil claims against those parties on behalf of the federal government under the False Claims Act and can be rewarded for it."

The federal False Claims Act is a federal law that renders it unlawful for any person or business entity to make false Medicare claims or otherwise defraud the federal government. It additionally allows a healthcare employee with information of fraudulent activity against the Medicare program to file a whistleblower case on behalf of the government. In exchange for their info and effort, the whistleblowers are entitled to collect financial rewards of as much as 15% to 30% of the financial by the federal government. The act likewise has stipulations for whistleblower protection against any company retaliation that may result from filing a case or agreeing to work with the federal government.

When a whistleblower steps forward with evidence regarding Medicare fraud, the case is submitted to a federal district court. It is put 'under seal' while the Department of Justice investigates the claim and the proof speaks with potential witnesses and seeks advice from experts and firm personnel. The government will then make a decision if it will participate in the lawsuit. If it does not choose to step in, the whistleblower still may continue the case by themselves.

Because healthcare workers place themselves at peril doing this essential work, the federal False Claims Act highly incentivizes the potential whistleblowers with a substantial portion of the monetary recovery. In an effective claim, the federal government can recuperate as much as 3 times its losses as well as charges for each event of fraud.
