The lawyer also proceeds to list out the common reasons for pedestrian accidents in New York City. These include speeding drivers, driver fatigue, making unsafe turns at intersections, aggressive driving, failure to

yield the right of way, backing up accidents, and school zone accidents.

Attorney Samantha Kucher also mentions that while the majority of pedestrian accidents are caused by negligent drivers, some could also be caused by the pedestrians themselves. The lawyer emphasizes that it?s important for every person to follow basic pedestrian laws.

Additionally, the lawyer also talks about the common injuries sustained in pedestrian accidents. This includes compound fractures, crushed bones, traumatic brain injuries, concussions, spinal cord injuries, internal bleeding, burns, scarring, or disfigurement, and many more including wrongful death.

In the new article, attorney Samantha Kucher discusses that according to New York laws, unless the pedestrian is entirely at-fault for the accident, they can still receive compensation based on the percentage of the other party?s fault.

Furthermore, the lawyer mentions that if you are injured in an accident caused by a negligent driver, you are able to recover damages by filing a claim with the driver?s insurance. These costs include medical expenses, any lost wages if you have not been able to work because of your injuries, potential future medical care, future lost earning capacity, property damages, pain and suffering, and emotional distress.
