In addition, the statute of limitations (SOL) is only two years for a bodily injury claim resulting from a car accident in the state of California. While it may seem that there is a lot of time to find the appropriate personal injury lawyer, that is not true. It is advisable to get the services of a lawyer as soon as possible to start setting up the case for success.

Every state has its own set of rules with the regards to the length of time within which the injured party can file a lawsuit. This is known as the SOL and in California, in general, it is two years for car crash cases for bodily injury. This means that the proper documents must be submitted to the appropriate courthouse within

two years from the date when the injury was incurred, including the day that the crash happened. Failure to do so will prevent the victim from recovering anything at all, no matter how good a case the victim may have.

There may be some circumstances where an extension or "tolling" may be granted. However, since complex legal principles are involved to determine whether the exception can apply, consulting with the right personal injury attorney Ontario residents can rely on is crucial. For instance, a tolling situation may occur if the victim is a minor. For that minor, the clock for the two year period doesn't begin ticking until their 18th birthday. The same situation occurs for victims who went into a coma. The clock will not start ticking until the victim wakes up.

Another situation where an extension of the two year time limit can be allowed is when the harm is not discovered immediately. In this case, the clock will start ticking from the day the injured person actually discovers the harm. This must be based on an objective standard, meaning it is the date when a reasonable person would have discovered the presence of the injury. This means that a reasonable individual would take the necessary steps to discover their health condition after the incident. That is why it is important to seek medical help as soon as possible after getting involved in a motor vehicle accident even if there appears to be nothing wrong. Ignoring the suspected health problems will not extend the SOL just because the victim failed to go to the doctor for a formal diagnosis.

Meanwhile, there are also some circumstances when the SOL can be shortened. This occurs for motor vehicle crash claims against any kind of public entity. Thus, those who get injured in a bus accident or a crash involving a police car will need to seek the help of a personal injury lawyer quickly since the time limit to file a claim against a public entity is six months after the accident. If the claim is rejected, the injury victim has six months from the date of rejection to file a claim against the appropriate municipal unit, including its division or subdivision. It is vital to consult an experienced lawyer because of the complexity of the rules involved.
