In addition, the lawyer adds that there are about 15,000 car accidents in the city of New York every month. Over two thousand of those accidents happen in the Bronx. A car accident can also leave the victim with injuries like whiplash, back and neck injuries, lacerations, traumatic brain injuries, and even death, according to the personal injury lawyer.

The attorney also says, ?Many companies in New York City rely on commercial trucks to provide goods and services throughout the city. And while the trucking industry is one of the most heavily regulated in the country and truck drivers are required to go through extensive training, truck accidents happen far too frequently, often leaving devastating injuries in their wake.?

Aside from the aforementioned, attorney Samantha Kucher explains that a personal injury lawyer can also help victims of construction site accidents. She adds that in 2018, Occupational Safety and Health Administration (OSHA) reported that 21.1 percent of worker fatalities in the country were in the construction industry.

Furthermore, the lawyer says that New York has some of the strongest laws regarding construction site safety. However, about 66 percent of construction job sites in New York still have some form of safety violation. This can be considered negligence and a victim may be able to seek compensation for their injuries.
