The lawyer says that the statistics paint a grim picture of the accidents and dangers caused by drunk driving in the state of New York.

According to the New York drunk driving accident lawyer, "When someone chooses to drive their car while drunk in New York, it is not only reckless, it is against the law. The drunk driver can be subject to serious legal consequences as well as civil action from anyone who is injured because of their reckless, careless, and negligent conduct."

The lawyer explains that New York sees quite a number of drunk driving accidents and injuries. According to the CDC, there are 3,752 alcohol-involved deaths from 2003 to 2012 in New York state alone. In New York, the NYPD reported that there were 2,683 accidents involving alcohol throughout the city in 2018.

In the new article, the lawyer enumerates the injuries that may be caused by drunk driving. These injuries include spinal cord injuries, traumatic brain injuries, fractures, internal organ damage, soft tissue injuries, serious head and neck injuries, disfigurement, paralysis, and even wrongful death.

The drunk driving lawyer also says that if someone suffered injuries in an accident with a drunk driver in New York, they may be able to receive compensation from the drunk driver. A victim may be able to hold the at-fault driver for medical costs, any lost wages, any future medical costs or lost wages, property damages, pain and suffering, disability, and wrongful death.

The accident lawyer also says, "Although insurance is the first resource we seek compensation from, the first settlement offer insurance companies make is usually grossly inadequate to cover all the damages that an injured party will suffer. Without significant negotiation, you will probably not get nearly what you are entitled to for your damages through the first insurance settlement offer."

Lastly, attorney Samantha Kucher says that drunk driving is against the law and if someone is a victim of a drunk driving accident they should seek the guidance of an experienced lawyer. Having a skilled attorney may be able to help the victim receive the compensation they deserve.
