The lawyer explains that in special needs trusts, the money can only be used by the beneficiaries when

planning to cover special needs like special education. The money from this trust cannot be used for basic necessities like housing or food expenses. Money from special needs trusts can also be treated as an income and affect SSI eligibility.

Attorney Carranceja-Gurski mentioned that funds from a special needs trust cannot be used for property tax, mortgage payments, rent, home insurance, utilities, groceries, and restaurant meals. It is also not allowed to give the beneficiary funds from a special needs trust as an allowance.

In the article, the special needs trust lawyer mentions that trust funds can be used to pay for special medical expenses that are not covered by Medicaid. This may include wheelchairs, special mechanical beds, and accessible vans. In some situations, the funds can also be used to plan recreational activities for the child.

Furthermore, attorney Kristine Carranceja-Gurski also adds that having a special needs planning attorney may be able to help set up a trust for the client.
