Depending on the offense, some consequences may include being required to notify neighbors of a felony status and losing potential employment opportunities. Citizens who have a felony conviction cannot be employed by the federal government, including all branches of the US military. Such individuals will also be

excluded from any form of government aid, even if they have previously paid into those programs, including those such as social security and unemployment, Section 8 housing and food stamps and federal grants and loans.

Regarding the average knowledge of an individual on legal matters, Attorney Bhatt states, "Most people are not familiar with the law. The average person's knowledge of the law is more than likely limited to what they see on television or read in newspapers and books. When they do get involved with the criminal law system, they do not know what to do, or how to handle the situation.
