According to the CDC, there were approximately 61,000 TBI-related deaths in the United States in 2019, an average of 166 deaths a day.

"Because the severity of a head injury may not be manifested immediately after a crash, all such injuries should be treated seriously. Seek medical help right away, and don't leave anyone who suffered a blow to the head (or even a 'slight bump') unmonitored," said a representative of the law firm.

According to the CDC, the second leading cause of TBIs are car accidents, comprising 17.3% of such injuries. The blog post's content provides information to drivers, passengers, and third-parties to understand the signs of a brain injury and urges them to seek immediate medical attention to protect their health and

well-being adequately.
