Attorney Russell Knight mentions that parenting time refers to the parenting schedule and decision-making responsibility refers to the parent who will make decisions for the child. Both of these are decided by the Illinois family law court if the parents are not able to agree on the terms.

In the article, attorney Knight also says that it is all well and good to set a specific schedule and specific decisions for the children. However, things can change dramatically. Most parents would sometimes want to know if having 50/50 joint custody would be an option for them. There are also four big factors that would require joint-decision making: Education, Health, Religion, and Extracurricular Activities.
