Auto insurance is legally mandated and it is not legal to own a car without auto insurance in almost all of the country. The government has imposed stiff consequences for those who drive without auto insurance. In Texas, those who drive without auto insurance face \$175-\$350 in penalties for a first-time offense. Subsequent offenses will result in larger fines and the car may also get impounded.

This strict enforcement of the law is because people must pay lots of money in damages if they get into a car accident without it. According to statistics from the Texas Department of Transportation, there were 12,907 serious injury crashes in Texas in 2019 with 15,855 people sustaining a serious injury. Since Texas is an at-fault state, this means that the medical expenses for those almost 16000 people came from the insurance

providers of the parties at fault for those accidents.

The kind of insurance one needs also differs based on the purpose of the kind of vehicle one drives. For example, private car owners need personal auto insurance which covers themselves and one or more family members. Commercial auto insurance is needed for businesses that have a company vehicle or an entire fleet of them. In this case, the company owns and pays for both the car and the insurance. Texas's minimum amount of liability coverage for each person injured in an accident is \$30,000. It must also offer up to a total of \$60,000 of coverage per accident. In addition, drivers must also have a plan that covers at least \$25,000 of property damage. This is referred to as the 30/60/25 rule. Individuals or businesses looking at auto insurance policies should ensure this type of coverage at a minimum. In case there are any questions, it is recommended to call an insurance agent to gain more clarity about what a plan covers.

Finally, one should consider the cost of the policy based on the premiums they will end up paying every month. The blog post says that one should predetermine what they can afford to pay monthly on their personal or commercial auto insurance in Texas. To add some context, the blog post also shares the statistic that most Texan drivers pay \$1,810 per year on personal auto insurance.
