The average price for full coverage of auto insurance in Utah is \$1,200 but it is still possible to find less costly alternatives that can provide the coverage that is needed or desired. The average price of auto insurance is actually dependent on a number of factors. These include: gender and age; where the person lives; the vehicle, such as its make and model; driving history; and the person?s credit score.

In the state of Utah, all drivers are mandated by law to carry personal injury protection that will pay for damages, injuries, or other costs resulting from a driving-related accident. The state also mandates that commercial vehicles should have a minimum of \$25,000 per person, \$15,000 for property damage, and

\$65,000 per accident for bodily injury.

It is important to note that auto insurance is a contract where the policyholder pays premiums while the insurance company protects the policyholder from losses due to accidents or theft. Auto insurance provides coverage for: property, which covers theft or damage to the car; liability, which is the legal responsibility of the policyholder towards others for causing bodily injuries and/or property damage; and medical, which will pay for the medical bills, including hospitalization, rehab, injuries, or funeral expenses if the injuries are fatal.

Liability coverage ensures that even if the policyholder was the one ?at fault,? the burden for paying for medical bills and car repair for the other party is on the insurance company. Liability insurance is required in Utah and in most states to protect all drivers. On the other hand, choosing liability-only auto insurance coverage means that if the policyholder is ?at fault,? their injuries and car repair are not covered if the policyholder is found at fault or by an ?act of God.? Meanwhile, comprehensive care insurance covers against ?acts of God? on the road. It also covers theft and all replacements or repairs against covered events that may include, natural disasters, fire, vandalism, theft, falling objects, and more. Comprehensive insurance is usually combined with collision insurance, which covers damages to the car due to a collision with another vehicle or object. Comprehensive coverage will typically cover the: cost of medical expenses for the other party if found at fault; theft of car; costs of property damage for the other party if at fault; damage to one?s car in an auto accident; damage to one?s car in collision with an object; and damage to one?s care due to ?acts of God,? such as storms, flooding, and falling debris.
