It is every victim's right to have an attorney at any time during the claims process and to file a case with the WCAB."

Personal injury law has to do with any injury that was caused by the wrongful behavior of another party, whether this is an individual, business, or entity. Under certain circumstances, a person can also be responsible for damages that they caused to another person even if they did everything possible that a reasonable person would do to prevent the harm, which is known as strict liability.

The most frequent cause of action to recover for damages is negligence. And there is negligence if the other party failed to use reasonable care. Negligence is typically present in vehicle collision accidents where a car collides with another vehicle or even a pedestrian or a cyclist. Negligence may also be found in other situations, such as in dog bites, faulty and unsafe products, and slip and fall accidents.

The court awards a remedy to the damaged party when all the elements of the cause of action have been proven. This remedy is typically in the form of money damages, but it can also include punitive damages and an injunctive relief.
