Meanwhile, she also wants to point out that the state law on child support is based on the concept that a child has the right to benefit from the income of both parents and it doesn't matter whether the parent is custodial or non-custodial. Thus, the income of the non-custodial parent is taken into account rather than the particular need of the child. And even if the custodial parent happens to be rich, or even a billionaire, the non-custodial parent is still required to pay child support. Minnesota's child support guidelines, therefore, are based on the income of the non-custodial parent. Although there are many factors to be taken into account by the court of law in specifying the actual amount of child support, in most cases, the amount determined based on child support guidelines. In general, the amount of child support is based on the non-custodial parent's net income and the number of children, but not more than \$6,975.

It is important to note that spousal maintenance or alimony, was previously simply awarded to stay-at-home mothers. Currently, courts have to ensure that they assess the particular financial situation of each divorcing couple instead of just basing their decisions on archaic gender roles.
