It is a tool that debtors have to discharge their debts if they get too overwhelmed. A bankruptcy case starts with the filing of a written petition with the Bankruptcy court. Petitions can be filed under either Chapter 7 or Chapter 13. Chapter 7, often called the liquidation case, involves turning over any non-exempt assets to a trustee, who sells them, and then pays the creditors. Chapter 13, on the other hand, requires a repayment plan, in which the debtor makes payments at least once a month to a trustee, for three to five years. Bankruptcy law is complex and ever-changing, a unique quality that requires bankruptcy lawyers to be on top of their chosen legal area of expertise constantly.
