Attorney Samantha Kucher adds that it will be helpful to have a camera or a phone ready when documenting damages in a truck accident. Taking photos will help ensure that any details law enforcement might have missed are well documented by the individual involved in the accident.

In the article, attorney Kucher explains that the major differences between a truck accident and a car accident are that trucks have bigger insurance policy coverage than private vehicles. This means that insurance companies will do everything they can to avoid any liabilities in a truck accident. Commercial trucks also tend to have greater collateral damage in an accident, victims may have more significant injuries and bigger medical bills as well. Truck accidents also have a greater risk of death compared to car accidents.

According to attorney Kucher, "In general, if a truck driver was negligent and he/she caused an accident that injured or killed someone else, then he/she will likely be held responsible for damages to those victims. But the trucking company, any owners leasing and maintaining the vehicle, as well as any other parties involved in the accident may be partly responsible for damages."
