Plantar warts, despite the rather humorous name, should be taken quite seriously since they have the potential to disrupt a patient?s life to a great extent. Advanced Foot & Decialists of Arizona emphasizes that patients should not panic, however, if they notice such a lump on one of their feet (or their child?s feet) since it is benign (not dangerous). However, they should not underestimate the amount of pressure even a small growth can place on their sole? nor the pain it can cause in turn. Luckily for the clinic?s patients, The Swift System has been cleared for use within the US, so this surface-based procedure can treat plantar warts without delay. It is considered a non-invasive procedure, and the clinic says patients are deeply unlikely to feel any lasting pain when they undergo it.

Patients who have already experienced Swift may marvel that it is much faster than other treatments. This is due to the fact that it is capable of directing a tightly controlled dose of microwave energy to the selected skin at a predetermined depth. Due to how lasers work, this also means that these microwaves can penetrate the surface of the skin without damaging it? and still target the tissue below quite effectively. The clinic says other treatment options, such as Cryotherapy, Salicylic Acid or even Laser Ablation cannot make this claim. In practice, patients who regularly visit the clinic for plantar wart removal will notice their procedures now take much less time (no more than 5-10 minutes long in most cases), among a host of other advantages.

One of the chief benefits is the fact that there is little to no need for padding or dressings following the procedure. Since the surface of the skin is unbroken, there is relatively little risk of infection or exposure.

All it does is agitate water molecules (much in the same way food is safely warmed in a home microwave), to the point that they heat up due to friction. The treatment actually delivers much less energy into the skin than other types of laser and electrocautery treatments that are actively in use today.
