In the article, attorney Kucher adds that medical negligence or medical malpractice refers to an act of a healthcare provider not meeting the norms or standards of their job. If the medical staff does not follow the standards of their job and their actions result in injury or death, the injured party has the right to recover compensation.

According to the personal injury lawyer, "Many times people who suffered a personal injury at the healthcare facility do not recognize it as medical malpractice. In many cases, be it a personal injury in general or medical malpractice in particular, the lawyers of the party causing the injury will try to settle the case. They might go as far as stating that a simple mistake happened and no one is to be blamed."
