According to Epiq, a legal research firm, after rising slightly from January to February, bankruptcy filings increased significantly from February to March. Within this time frame, consumer filings jumped by 34 percent and commercial cases 26 percent.

Despite this drastic month to month increase, bankruptcy filings overall are still down from last year?s statistics. In fact, comparing the first quarter of 2021 and the first quarter of 2022, there was a 17 percent decrease in new filings.

As for the recent spike in cases last month, one plausible reason for it could be that businesses and

individuals have found themselves needing to seek debt relief after certain COVID relief government aid

programs ended.

Looking from another angle, executive director of the American Bankruptcy Institute, Amy Quackenboss,

recently stated: ?Amid rising interest rates, growing inflation concerns, worker shortages and supply chain

challenges, access to bankruptcy is imperative for struggling consumers and businesses.?
