?The momentum and overall increased force of head-on collisions result in more fatalities and catastrophic injuries than any other car accident on our roads. The lawyer explains that head-on collisions happen when two cars are moving in the opposite direction and crash with each other front-to-front. Institute for Highway Safety reports that 59% of all passenger vehicle occupant deaths in 2019 are attributed to head-on collisions, despite only representing a small percentage of

car accidents in general.

Attorney Samantha Kucher adds that the force of the impact of head-on collisions is equal to the combined speed of both vehicles. When a vehicle moves forward, the people inside are also traveling at the same speed. In accidents like head-on collisions, both the car and the bodies decelerate upon impact and can result in serious injuries and fatalities even with the safety restraint system of the vehicle.

In the article, attorney Kucher says that injuries sustained in accidents involving head-on collisions are often catastrophic and affect victims for a long time. Some even end up in fatalities. Sometimes, even with the proper use of seatbelts and other safety systems, head-on collisions are still very dangerous.

According to the personal injury lawyer, "After the fault is established, the injured party must also establish injuries. New York has no-fault insurance laws that allow injured parties to pursue compensation for medical bills, lost wages, and other expenses from their own insurance company after an accident. In addition, those who are injured in a head-on collision can pursue recovery from pain and suffer from those who caused their injuries. In order to do so, they must meet what is known as Serious Injury Threshold."

Lastly, attorney Kucher emphasizes the importance of seeking the help of an experienced head-on collision lawyer. Having a skilled attorney may be able to help the victim receive the compensation they deserve for their injuries.
