construction, violations of building code, damage from termites, and items stored on drywall instead of joists in the attic.

Attorney Samantha Kucher also adds that property owners are required to ensure that their buildings are up to safety standards. If a ceiling collapses and results in serious injuries, the property owner or the landlord may be held liable. The liability for the accident usually depends on the circumstances surrounding the ceiling collapse.

In the article, attorney Samantha Kucher says that if a ceiling collapses, it creates a dangerous situation for the tenants. The building is exposed to the elements of nature and has no cover. After a ceiling collapses, debris can also fall inward and cause head, neck, or back injuries.

According to the injury lawyer, "You must prove negligence on the part of a property owner if you've experienced a collapsed ceiling and suffered injuries. Premises liability makes the landlord or property owner responsible if you can prove negligence. Property owners have a duty of care to ensure that their buildings are properly maintained in a reasonably safe manner so that residents, tenants, and visitors can remain safe."
