Like all warts, plantar warts are due to the human papillomavirus (HPV) virus, particularly types 1, 2, 4, 60, and 63. Plantar warts are typically difficult to treat because underneath the skin, they have finger-like roots deep inside the skin and grow, making them very hard to treat effectively from the surface. The Swift device is an advanced, FDA cleared technology that has proven to be highly effective in the removal of plantar warts. It delivers low dose microwave energy via a specialized probe that targets and effectively treats the underlying HPV virus by activating a natural immune response in the body. This addresses the root cause of

the plantar wart and not just the symptom.

The Swift Microwave Wart Therapy machine has been observed to be effective for the removal of plantar warts. This advanced microwave therapy machine generates microwave energy that is directed to the infected tissue using an applicator in order to quickly elevate tissue temperature. The purpose for this is to stimulate the patient?s natural immune response against the HPV virus that causes the skin lesions or warts. Plantar warts are usually found on the soles on the feet and those who have them would naturally want to have them removed because they are quite painful because the pressure exerted on the feet causes a lot of pain and discomfort. The Swift protocol is typically made up of 3 to 4 treatments that are spaced four weeks apart to ensure that the treatment is aligned with the natural immune cycle of the body. Each treatment session is quick and typically lasts for 5 to 10 minutes, and no bandages are needed because there is no breaking of the skin and there is minimal debridement. No home treatment is required in between sessions. And patients would be able to return to their normal activities right after each session. Furthermore, it has been observed that the Swift treatment has a substantially higher efficacy when compared to other treatment methods because it takes advantage of the patient?s own immune system.

It should be noted that while the pain during treatment is variable and depends on the patient and the lesion, most patients usually experience some level of discomfort as the infected tissue temperatures are rapidly increased for about two seconds. However, the pain immediately subsides after the energy delivery is stopped and there is very limited post procedural pain.
