According to the firm, UMBI is a type of insurance coverage that can help cover an accident victim's medical bills and other damages if they are in an accident with another driver who has no insurance. Should this type of coverage be active when the accident occurs, they may be able to file a claim with their own insurance provider (up to the limit of their coverage).

Alexander Napolin of Napolin Accident Injury Lawyer explains that UMBI is not required by law in the state of California, but it is still advisable to obtain this form of insurance because it can drastically affect the

aftermath of an accident in the event the other driver has no insurance. This is due to the fact that many drivers are known to take to the roads without adequate insurance, despite this being against the law, and Napolin says everyone should take this additional step to protect themselves as part of their liability insurance policy. As many as 1 in 8 drivers are estimated to be uninsured, and an accident involving such a driver would potentially leave the insured party fully responsible for all the damages on their own. Given the exorbitant costs accident victims are known to face, from medical bills to damaged property, the firm recommends that concerned drivers purchase at least \$100,000 in coverage. However, should they need any help filing such a claim (or in the event they unfortunately do not have this type of coverage and an accident occurs), they should pay Napolin's office a visit.
