The lawyer explains that the share of electric scooters (e-scooters) in urban traffic has been increasingly growing in recent years. However, with the increase in e-scooters on the road, the rise of accidents involving

them has also been growing. The safety situation of e-scooters is insufficiently researched in terms of injury outcomes and kinematics.
