the statute of limitations has not expired. After a car accident, the statute of limitations for filing a lawsuit is

three years. To recover damages, survivors of a fatal accident may file a suit.

these laws might be restricted. If another driver partially caused the accident, they may also be held

accountable for the injuries of the victim.

According to attorney Kucher, "While there are a variety of causes for car accidents, there are some car

collisions that are more common in the city of New York. New York City street is a busy place which results in

a lot of car and motorcycle collisions. Driver distraction or inattention, drunk driving or drug-impaired driving,

reckless car driving, and many others are just some of the most common causes of car accidents in New

York."
