The Saorsa Swift machine employs FDA approved microwave therapy technology, which has been proven to be highly efficacious in removing plantar warts. A vital feature of the Swift machine is its specialized probe that looks like a wand and is used to accurately direct the low dose microwave energy to the area that has been affected by the HPV virus. The microwave energy causes a rapid rise in the temperature of the targeted tissue and this will trigger the body?s natural immune response. It should be noted that the probe or applicator has a built-in sensor that detects if the tip of the applicator has previously been used. It will only allow operation if a new and unused tip is attached to the applicator. This is designed to prevent cross contamination.

It is also important to note that the microwaves used are safe. First of all microwaves have been used in clinical applications for more than 30 years. The same basic technology that is used for the Swift machine is also being applied for the treatment of liver, lung, breast, and kidney cancer in various countries. Second, microwaves are a type of non-ionizing radiation, which means that they can?t cause damage to the DNA of living things. Third, the Swift system only delivers very low energy levels when compared to other forms of electromagnetic energy. The energy delivered is just enough to agitate the water molecules and cause friction and increase the temperature. In fact, the amount of energy is considerably less than the energy used in most laser and electrocautery treatments.

The Swift procedure will only need 3 to 4 treatment sessions and these are scheduled four weeks apart to
