And as the severity of a head injury will not immediately be apparent after the accident, it is essential that all such injuries be treated seriously. That is why Franklin D. Non-economic damages, which are much more difficult to calculate, attempt to put a monetary equivalent to the grief, pain, and suffering experienced by the victim's family.
