Can I Recover Compensation If I Was Partially At Fault? You are still able to be compensated for your injuries even if you are partially at fault. The judge will determine all party?s degree of fault, if the other party who caused your injuries was more at fault than you were, then a percentage of their liability will be applied to your personal injury case. This is called comparative negligence, and is usually the percentage that the judge determines is fair and just. For example, if your total of damages for losses of a claim came to \$10,000, but you were considered to be 25% at fault, you would only receive \$7500 in financial compensation.

Make sure you note your injuries, especially if they?re serious and could be long-term or permanent.
