In almost all instances, these are not mere accidents - they are the direct result of intentional negligence, and the property owner must be held accountable for your damages and injuries."

The lawyer explains that ceiling collapses and other building failures can be avoided by the building

supervisor or property owner. Most ceiling collapses occur due to poor maintenance, leakage, and landlords neglecting to properly care for the property.

Attorney Samantha Kucher states that it takes little for a falling ceiling to cause serious injuries and damages. A partial bathroom ceiling collapse could cause a person to be knocked backwards while showering. This could cause serious injuries such as concussions or worse, possibly a traumatic brain injury.

The article also mentions that victims may have to pay their medical expenses resulting from injuries suffered in an accident. Victims with serious injuries can face thousands of dollars in medical bills, lost wages, and other expenses. These costs are not supposed to be the fault of the renter. The landlord or property manager should be held liable for the accident.

Furthermore, attorney Kucher identifies potential issues that could lead to ceiling-collapse accidents. These problems include a minor problem with the water heater, which could cause sheetrock and/or wood to rot; snow accumulation on a roof; heavy items stored in the ceiling; and cracks within the ceiling.

Lastly, the accident lawyer emphasizes the importance of having an experienced lawyer if someone has been a victim of a ceiling collapse due to the negligence of an owner. Having a skilled lawyer may be able to help the victim receive the compensation they deserve.
