The lawyer explains that New Jersey gun laws require that all individuals be properly allowed to possess

guns, must have the right identification, and be of the appropriate age.

Attorney Adam M. Lustberg states that firearms cannot be transported in New Jersey unless there are specific circumstances. This includes if the person transporting firearms is a licensed firearms seller and transports firearms within the course of their business. A few other reasons could be that if the person transports firearms between dwellings, between a dwelling and a business, or between a home or business with a firearms repair shop.

The gun crimes lawyer states that anyone transporting firearms to a shooting site, hunting site, or weapons exhibition is also allowed.

The article also addresses who can legally purchase a weapon in New Jersey. Attorney Lustberg states that every state has its own rules and guidelines when it comes to the purchase and possession of firearms. New Jersey prohibits anyone under the age of 18 from applying for any type of firearm license.

Attorney Lustberg also says that individuals who have been convicted or placed under a domestic violence order are prohibited from owning or possessing firearms. The same applies to those who have been convicted of violent crimes or have a history in conspiring with others to commit such crimes.

Lastly, the lawyer emphasizes that it is important for anyone who is charged with a gun crime to seek the help of an experienced defense lawyer. Having a skilled gun crimes lawyer may be able to help the defendant protect their freedom and understand their rights in the case.
