Attorney Samantha Kucher says there are specific right-of-way laws in New York. State legislators have enacted stricter laws and penalties to ensure everyone knows their rights and responsibilities when they're on the road. New York City is still a hotbed for right-of-way violations.

In the article, the lawyer says that failure to yield often occurs at intersections. This includes failure to obey signs and signals, failure to yield when there are no signs or signals, left-hand turns at intersections, T-intersection right-of-way, and four-way stops.
