They encourage such workers to request a workers' compensation claim form from their employer right away after reporting a work injury. In response to this notification, the employer is required to provide medical care, and the insurance company will then decide whether or not to assume culpability for the harm.

Once it has been established that the worker's health condition was brought on by a work-related accident or other reasons, they are eligible for four major benefits. One advantage is receiving medical care to mend or treat the work-related damage. To make up for the lost income resulting from the incapacity to work owing to an illness or injury, there is also a temporary disability benefit. When a work-related disease or injury results in permanent disability, there is also a permanent disability benefit. The job retraining voucher is the last option available to employees who are unable to return to their prior position due to an injury or illness-related incapacity.
