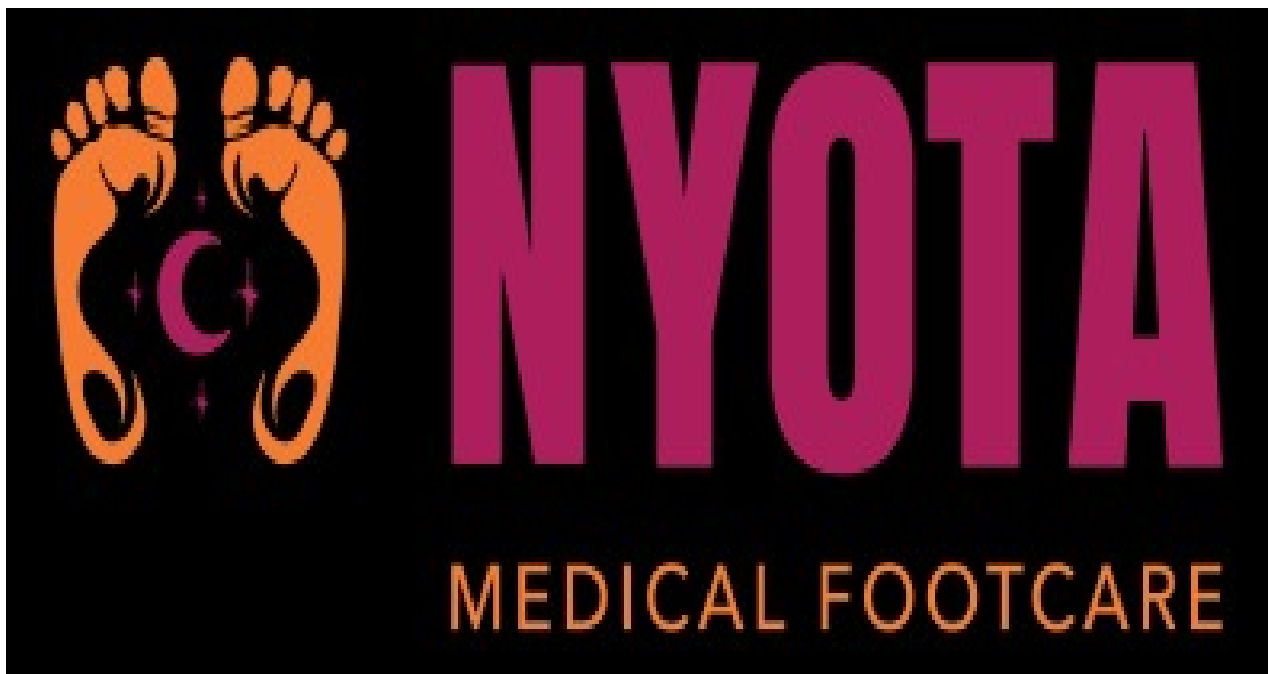

Plantar warts, sometimes known as verruca, affect the bottom of the feet, causing small, fleshy growths to appear. These growths may be rough or grainy, and they cause hardened, thick skin to form (where a wart has grown inward) along with black pinpoint in the center of the growth (which are clotted blood vessels). Plantar warts are caused by the HPV virus when it enters the body through tiny cuts, breaks or weak spots in the skin at the bottom of the feet. The virus can thrive in warm, moist environments such as locker rooms and swimming pools, making them a common ground for infection.

While plantar warts are not often a serious health concern ? in fact, they can fade without treatment eventually ? they can be quite painful where pressure is applied on them, leading to affected people experiencing trouble walking and engaging in daily activities. Nyota Medical Footcare, PLLC advises that it

may actually take up to a few years for such warts to disappear; those who want to alleviate the pain brought about by plantar warts should look to get them treated. However, self-care methods or other traditional methods (such as salicylic acid, cryotherapy, chemo-based fluorouracil or bleomycin and surgical removal) tend to be painful, invasive or require multiple sessions to complete.

On the other hand, Saorsa's SWIFT technology provides quick and easy relief. Using state-of-the-art technology to deliver precise, highly controlled microwave energy into the specific areas of the skin where plantar warts have formed, the SWIFT method stimulates the patient's body into a healing response and treats plantar warts at their source.
