At the time, it was not understood that asbestos exposure could lead to serious health problems.

Now that we better understand the dangers of asbestos, it's important to protect families and employees from this harmful material. Older homes and buildings are currently the primary source of asbestos in the United States, making contact easier than many people realize. If asbestos is found and is in good condition, then it likely doesn't present a health risk unless there's a chance it will be disturbed. However, if the asbestos-containing materials (ACMs) have been damaged or are at risk of being disturbed then Precision Environmental Services can work with you to create an asbestos management plan or perform needed asbestos removal.
