Premises liability is a part of personal injury law that states that a landowner has liability for certain torts that happen on their property. For premises liability to apply, three conditions must be deemed true. First, the individual being charged in the civil suit must own the property or premises. Second, the individual or party that is injured should have been invited onto the property or should be a licensee. In other words, the premises liability does not apply if the person is a trespasser. Finally, there should be irrefutable proof that the property owner failed to duly care for the safety of those using the premises. The plaintiff's injury should be directly attributable to the result of the property owner's negligence or wrongful conduct.

Some common dangerous situations on properties include objects that are not stored correctly, parking lots

that are not well lit, stairways that are not properly maintained, wet floors that are not marked, elevators and escalators that do not work, ice and snow that has not been removed, and construction areas that are not protected. In some cases, if a person is assaulted on a property that they are visiting, the property owner can be held liable for failing to provide adequate security measures to the assault victim. These cases are referred to as ?third-party premises liability.?

Nugent, P.C. talks about the need to file civil charges in personal injury cases involving premises liability by saying, ?There is no saying when misfortune will strike. You can be extremely careful in your own home. However, when you are visiting a commercial property such as an office building, restaurant, government building, shopping center, hotel, apartment complex, or even a park, the conditions are not going to be under your control. You have to trust that the owner of the property has taken the necessary precautions to ensure that their premises are safe for all visitors. However, providing that level of care and safety requires a full-time staff and up-to-date equipment. These are recurring expenses that cost a significant amount of money. A lot of landlords will go to great lengths to cut corners to squeeze every last penny out of their property investment. This ends up jeopardizing the safety of the people who visit the property.
