If they aren?t going to stop every vehicle, they need to come up with another impartial basis such as stopping every third car.

In the article, the lawyer says that the DUI checkpoint should have safety precautions so that drivers can stop or drive through the checkpoint safely. There should be signs informing drivers about the checkpoint along the road leading up to it.

According to the DWI attorney, ?In New York, it is perfectly legal for the police departments to set up sobriety checkpoints where officers may stop and check drivers for a short time to find out if they are driving in a state of intoxication. However, these checkpoints have to conform to the legal limitations placed upon them and must be conducted in a fair and impartial manner.?
