“Motorbike accidents result in catastrophic injuries and damage,” the post notes. “Unlike other motor vehicles, such as automobiles and trucks, motorcyclists are not protected by seat belts or enclosed within vehicle structures. A collision with a bus, train or other vehicle at high speeds can result in contact with the road or worse, another fast-moving and heavy motor vehicle. So, if you or a loved one has been injured in a motorcycle accident, you’ve come to the correct place.”

One reason motorcycle accident victims may require professional legal assistance more than people involved in other types of road incidents is the sheer degree to which they can be injured. In addition to pain and distress, they may suffer broken or fractured bones, spinal cord or neck injuries, traumatic brain injuries (TBI), paralysis, PTSD and a host of other conditions. This may in turn cause them to lose a significant portion of their income earning potential even after they recover ? and many accidents of this type end with the victim never making a full recovery. Amputation injuries, for instance, are another risk that can lead to severe loss in quality of life and more.

Alexander D. Napolin of Napolin Accident Injury Lawyer explains that the risk of such severe injury makes it much more likely that motorcycle accident victims will have to contend with massive bills and expenses, beginning with their medical debt. They will not be able to work after the accident either, so that constitutes an immediate loss of income (separate to loss of future income potential). If a victim is unable to support themselves financially and wholly dependent on medical intervention to survive, a suitable settlement may be the only way for them to start rebuilding their life again.

The post says, ?Problems that are long-term and will severely affect a person?s capacity to carry on a normal existence are examples of lifelong conditions. In such circumstances, the worth of a lawsuit may be significant, as the victim is not at fault and adequate insurance was in place at the time of the accident. However, seemingly small issues that do not require long periods of medical treatment may be worth a lot if handled early by an experienced litigator.? Unfortunately, while the victim, their family and their attorney will be fully aware that they deserve compensation for their pain and suffering, other parties may disagree. The person or persons responsible for the accident (due to negligence and so on), for instance, may claim otherwise. Similarly, should the victim have insurance that is expected to cover such incidents, they may discover that their insurer disagrees about the validity of their claim. Insurers have an incentive to deny claims as it can affect their profits, so the victim?s best advocate will always be their accident injury attorney ? who is legally and ethically bound to advocate in their client?s best interests.

In this order, they should get medical attention if they are injured, gather evidence from the accident scene (photos, videos, etc.), get the contact information of any witnesses and call an experienced Ontario motorcycle accident lawyer.
