Napolin Accident Injury Lawyer begins by confirming that Workers' Compensation is codified in the California Labor Code. Under the law, it is mandatory for every employer in the state to have an insurance plan to cover for employees in case of work-related injuries or illness. In exchange for this insurance plan, employees are not allowed to file lawsuits for personal injury or work injury, such as negligence, against their employer in most situations. Along with the codification of the Worker's Compensation, the State has also established an administrative court known as the Workers' Compensation Appeals Board (WCAB) where lawyers can appear and present disputes to be heard by judges.

Lead attorney Alexander D. Napolin says, "If you are injured in the workplace, the biggest mistake you can

make is not to report those injuries to your employer right away. You should report any injuries to your employer as soon as possible and request a workers' compensation claim form. Your reporting the injury triggers your employer's duty to provide medical treatment, while the insurance company decides to either deny or accept liability for your injury.?

Workers' compensation functions as a simple no-fault system. Since job-related injuries can create many problems for workers and their households, workers' compensation benefits can mean the difference between a person's life being completely ruined or them having the support they need to carry on as reasonably as possible. Once it has been established that the health condition has come about due to an accident on the job (or other factors regarding the job), workers' compensation law kicks in and the worker is covered.

Under the law, there are four main benefits, the availability and amount able to be collected varies significantly depending on the nature and extent of the health condition or illness as well as the administration of the policy by the insurance company. These four main benefits are medical care to treat the injury, temporary disability (provided as wage replacement while they recover), permanent disability benefit for employees who have suffered more permanent injuries and a job training voucher that can be used to retrain an employee who cannot return to their old job because of what has happened.
