The "best interests of the child" standard is from Section 518.17 of the 2015 Minnesota Statutes. It is important to note that while it is not uncommon for parents to disagree on child custody or visitation, it's important for both parties to understand that getting into emotionally charged arguments about what is best for the kids is typically destructive and does not move the situation towards the best resolution.?"

According to the law, there are various kinds of custody. Physical custody provides a parent the right to have

a child live with him or her but it does not mean total control over all aspects of the child's life. Legal custody provides a parent with the right and responsibility to decide with regards to issues involving the child's upbringing, such as schooling, medical care, and religion. Typically, courts will award joint legal custody but there are some situations where sole legal custody may be awarded. Sole custody grants just one parent either physical custody or legal custody for those situations when the other parent has been shown to be unfit. However, it should be clarified that this will be based on the Court's criteria and not just because one parent believes the other parent is unfit. And finally, joint custody may be granted to both parents even if they no longer live together.

Meanwhile, Dakota County is the third most populous county in Minnesota and those who are facing child issues are advised to consult a Dakota County divorce attorney such as Lisa Amundson.
