The Healthcare Workers Minimum Wage Ordinance, which was signed on July 7, 2022, goes into effect on August 13, 2022. The law applies to all healthcare employees who work in privately owned facilities within the City of Los Angeles. There are more than 100 facilities in the city whose employees stand to benefit from the wage hike. The law made it to the Los Angeles City Council due to the efforts of the healthcare workers union Service Employees International Union-United Healthcare Workers West (SEIU-UHW). The union consists of frontline healthcare workers such as respiratory care practitioners, dietary, environmental services, and nursing staff who work in some of California?s largest private sector hospitals.

However, there has been opposition to the bill by local governments in other cities including Anaheim, Long Beach, Culver City, Downey, Baldwin Park, Lynwood, and more. The limitations of the bill are being brought to the attention of the lawmakers in the aforementioned cities by a coalition named ?No On The Unequal Pay Measures.? This coalition is funded by Kaiser Foundation Health Plan and Dignity Health, a non-profit public benefit corporation. The coalition raises the concerns that the scope of the bill is too narrow as it excludes workers at 80% of health care facilities in the state. The coalition makes a case that the proposed minimum wage hike is inequitable to workers, harmful to patients, and risky for the communities that it intends to benefit.

According to healthcare experts, the jury is still out on the efficacy of the proposed increase in the minimum wage. The measure was implemented to reward the efforts of the healthcare workers who in recent years have gone through what was, arguably, the worst-case scenario for the country?s health care system? the

2020 coronavirus pandemic. The bill also aimed to make the healthcare field in several California cities

attractive to new workers as it is currently being pushed to its limit due to understaffing and high turnover

rates.

A spokesperson for Simplicity Title Loans reacted to the passing of the law by saying, "We will have to see

the effect the raising the minimum wage is. In theory, it should attract more workers." Downey residents who

working in private healthcare facilities in the city. However, as the coalition believes, the full effect of the wage

hike on the city?s healthcare ecosystem, whether positive or negative, will only be understood with time.
