The Saorsa Swift Wart Removal System rapidly increases the temperature of soft tissue to coagulate it. The result is a non-invasive procedure that addresses the root cause of the condition. Since the system delivers a highly targeted and controlled dose of energy to a pre-determined depth in the skin, it solves a lot of the problems that other traditional treatments of plantar warts suffer from.

For example, cryotherapy is one of the most popular treatments for plantar warts in the country. However, it uses liquid nitrogen to freeze plantar warts which can penetrate the skin and form blisters. The procedure, therefore, ends up being painful and it takes a week or so for the dead tissue to slough off. Other treatments such as salicylic acid and laser ablation are similarly destructive to the skin surrounding plantar warts.

The Saorsa Swift System is much gentler and more precise leading to almost painless treatments that take less time. Saorsa's microwave-based plantar wart treatment system has been used in more than 30,000 procedures across the UK, Canada, and Australia. It was recently approved for use in the United States by the FDA.
