Other legal dependents and family members could also be eligible to file a claim.

According to Attorney Keetick Sanchez, wrongful death can be treated in the same way as a personal injury case. The wrongful death case is filed by the estate's family members. To prove negligence, a wrongful death case must be proven against the defendant. Negligence refers to behavior that is not consistent with the standard of care that an ordinary person would use in the same situation.

?It?s important to keep in mind that a wrongful death case is not meant to make up for your grief. Although it is a very emotional time for the family, it is also often a financially difficult time. A wrongful death claim is meant to provide a financial means to offset economic and non-economic damages that your loved one would have been able to claim had he or she survived,? the accident lawyer says.
