Compensation is calculated based on a number of factors, however, and agreeing to settle on the initial amount offered by an insurer is more than likely to result in the victim receiving a much lower figure than they are due.

One other aspect that should be considered is the potential for missed work. If an accident victim no longer has a reliable way to get to work, this can result in lost wages that directly stem from the accident. This cost may be accrued for the duration the vehicle is unusable, but they should consider that they may also be worse off if their inability to go to work leads to them being let go altogether. The same is true if they suffered a serious injury in the accident that negatively impacts their ability to function, both at their place of employment and at home. Kenneth S. Nugent, P.C. points out that contractors who frequently engage in heavy physical activity are an excellent example of a job where even minor injuries can have serious repercussions (such as delaying their recovery or impeding it completely), but injuries that only affect the victim?s comfort and quality of life are not discounted either.
